

2019 Troop & Family “My Sales” Booth Request Form

My Family & My Troop Sales are organized by an individual family or a troop at sites that are not on the Council Booth Sales list. To schedule a My Sale, use this My Sales Request Form and see guidelines below.



ATTENTION LOCATION MANAGER: Girl Scouts should not begin coordinating and securing locations for booth sales until November 1st. Girl Scout troops are to follow location management suggestions to avoid interference with normal business operations. Your support of the annual Girl Scout Cookie Program is appreciated! If you have questions, please call 972-349-2404.

Girl Scout Volunteer - My Family Sales begin 01.11.19: You must complete one form for My “Family” Sales. Up to 5 dates may be approved on one form. Additional dates require additional forms for approval. Once the form has been approved & signed by location management, turn in the form to your TCM at least 48 hours prior to the start of the booth sale. They will then enter the data into eBudde for SU approval at least 24 hours prior to the booth sale.

Girl Scout Volunteer - My Troop Sales begin 01.25.19: You must complete one form for “Troop” Sales. Up to 5 dates may be approved on one form. Additional dates require additional forms for approval. Once the form has been approved & signed by location management, enter the data into eBudde for SU approval at least 24 hours prior to the booth sale.
